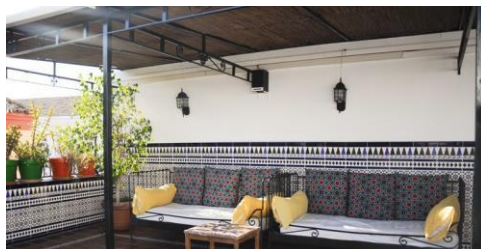
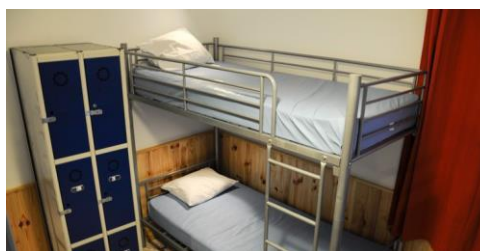

LAW OF TOURIST ESTABLISHMENTS IN CATALONIA

Since November 2012, the new Tourism Establishments Act entered into force In Catalonia. This law provides that for all stays in hotel establishments, Tourist apartments, campsites, farmhouses, hostels, etc ... a fee will apply tour.

The maximum amount to pay will be the equivalent of 7 nights per person

There are exemptions of this rate:

A) the stays subsidized by social programs of an administration Of any member state of the European Union.

B) Children under 16
